

The Independent Sector Complaints Adjudication Service (ISCAS) is a UK Department for Health approved not-for-profit independent dispute resolution service for the Independent Healthcare Sector. Recognised by the CQC, HIW, HIS and RQIA, subscription to ISCAS provides subscribing organisations with the independent review of complaints that is required by the four UK nation regulators.

ISCAS subscribers can adopt the industry recognised ISCAS Code of Practice for standards in complaints handling which provides a roadmap for effective complaint handling and a final independent adjudication process for deadlocked complaints provided by expert ISCAS adjudicators.

Subscribers to ISCAS have access to:

- The adoption of the ISCAS Code
- Providing patients with access to independent adjudication for deadlocked disputes
- Learning, feedback and support from ISCAS experts

Governance and stakeholder engagement are an important element of ISCAS's work and our Advisory Board chaired by Baroness Fiona Hodgson CBE comprises of stakeholders from subscribing businesses and patient representatives.

ISCAS is owned and operated by the Centre for Effective Dispute Resolution, one of Europe's largest dispute resolution charities.


